Speaking of showing support, thanks to all of you on email that voted (pro and con) to the potential expenditure of up to \$250 to help our one-day trips actually happen. I will keep you posted on how much and for which trips any money is used. Tom Vannuyen (Holiday Valley, 1/17/03), Margaret Proctor and Paul Antzak (P-n-P/Wilderness Lodge, 1/20/03) worked hard to pull together the best trips they could.

Both trips were just a bit over the \$100 loss mark at the time of the email requesting the approval to spend up to \$250 - in other words, approve the running of the trip even though it might lose that much money. (\$100 is the upper limit that the board can approve to spend. Anything over that must be approved by a majority of a quorum of the membership at a meeting.)

We've never before used email for any money expenditure approval and we have no plans to use that again. I felt that this was an emergency type of situation. I did take a liberal and "electronic-centric" (if you will!) interpretation of the constitutional guidelines for expenditure of funds. The rationale used was:

Out of our almost 200 members, 140 use email.

So, if we can get over 70 (I asked for 75) of those email members to approve, then we're OK.

75 votes to OK the money is way more than the number of people that show up to meetings, let alone be a majority of the people at a meeting.

I do understand that all of our non-email members were left TOTALLY out of this loop. I'm sorry. I wanted to get an answer (to cancel or not to cancel) for the trip coordinators as quickly and as fairly as I could. This was the best plan I could come up with at the time. I also understand that only those who went on these two trips benefited directly. (Please understand that was more than fifty of our members between the two trips.) *Feel free to blast me at the meeting!* I can take it! This topic will be on the agenda and open for discussion. I'd love to hear your ideas for better ways to operate.

And, don't forget to take a moment at the next club meeting to tell Al Linne, Margaret Proctor, Tony Shook, me (the 3-VPs and the pres) and/or Annie Easley (Chair of the Trip Planning Committee) why weekend trips just don't seem to work out for this club. We need to know why. Give us your thoughts so that we can better plan trips for the coming years. Thanks in advance.
