I found good runs again on the north side but to get to them required skiing over some very icy areas. So between the ice and fog it was a frustrating day for skiing. However, I did find a nice little heated "refuge" in which to relax and enjoy a delicious crepe at the bottom of the mountain.

On Thursday, I walked all over the walled city and ventured outside of the old city to visit the ice and snow sculptures and other Carnival exhibits. I especially enjoyed "Le Petite Huskies," three little frolicking adorable Husky puppies. One appealing sculpture was of a com-mercial-type airplane complete with engines and a window with another sculpture inside of a passenger looking out.

I found a unique store where fur pelts are assembled and sewn into various garments, including coats, hats, capes, vests, head bands, ear muffs, etc. and found several nice shops carrying arts, crafts and other products made by Canadian artisans.

Thursday night I joined a group of ten at a revolving rooftop restaurant for a buffet dinner with panoramic views of the city. The view was enhanced by lighted areas such as the Chateau Frontenac and the Ice Palace. It was a pleasant way to wrap up our vacation and to compare experiences with others on the trip.

End of the Year Race Report:
Last month I promised to wrap up the season for you, so here goes.
On the last weekend in February, CMSC conducted their annual Combined Championship at Bristol Mountain. Excellent conditions and fast courses made for fantastic racing action. A change in the rules this year meant every run would count, as the individual Combined champions in each class would be determined by total combined time for the five runs in three race events. The team championship would be determined by total points, as usual. First up, the Super G. On of the fastest Group $1 \& 2$ courses ever set by Bristol meant even the $B$ Men were breaking the 60 second barrier on Comet. In years past, Mike Kupiec's GPS showed a peak speed of 47 mph with that kind of time. Most racers were seeing speeds they had only dared dream of before. Of course those dreams may have been nightmares for some. Speed can do that to you. Sweeping turns and delay gates, with two opportunities for air, had some feeling like Bode Miller at Snowbasin, and others feeling like Herman Maier at Nagano. Groups 3 \& 4 had their own adventures over on Galaxy as well. When all was said and done, our need for speed showed through, as the Team came up with a Perfecta finish. Bruce scored a first in CCM, Lisa a second in BW, Elise a third in CCVW, and Mark a fourth in BM. 72 team points had us in fifth place, of seven teams in Division 2, beating Goodyear and Snowballers.

When the courses were reset, it was time to run the GS. Groups $1 \& 2$ both got to run top to bottom again on Comet, while Groups $3 \& 4$ gave it another go on Galaxy. Speed must appeal to our team, as we narrowly missed a repeat Perfecta. Bruce was leading CCM handily after his first run, but had an unfortunate DQ on his second attempt. The team rallied with Mark placing second in BM, Elise third in CCVW, and Lisa fourth in BW. The DQ cost us, but 47 points placed us seventh, and kept us ahead of Goodyear, while Snowballers pulled away.

Sunday's final event, the Slalom, is always a challenge. After a long day on Saturday (and long night for some), it's always tough to find the endurance for two long, all out, slalom runs. The team reached down and found that something extra, and pulled off a strong showing in this technical event. Bruce recovered his technique and kept his skis on, to finish second in CCM,

Elise matched him with a second in CCVW, while Mark and Lisa both brought home fourths in BM and BW, respectively. As for Combined, 64 team points in the slalom was enough to give us another 5th place in Division 2, again besting Goodyear and Snowballers. Overall, we had enough to remain a respectable 6th of seven for team Combined. An excellent finish for four racers on the hill, taking two of three from Snowballers, who had 6.

Now for the Individual results. They say the Masters doesn't start until the back nine on Sunday. Well, with total time counting, I say Combined doesn't start until the second run in the slalom on Sunday. With 3 finishers out of 4 competing, Elise scored a convincing second place finish overall in CCVW. In a class full of talented competition, with 6 finishers out of 8 competitors, Lisa skied to a consistent second place finish in BW. In BM, with 7 finishers of 10 competitors, I found myself in second place by 13 seconds after the first run on Sunday. I knew the end result wasn't up to me, except to finish my run and hope for the best. After crossing the line and anxiously waiting for the leader in BM, imagine my surprise at seeing Matt Votral hiking up the course for the gate he missed, while I begin counting: 1 Mississipppi, two Mississippi... I get to fourteen as he crosses the finish line, knowing that it's going to be close. Close it was, but 0.31 seconds is enough. In an eerie reversal of last year's result, I manage to win Combined over Matt, my first in 10 tries in BM. Kudos to Matt, for having the drive to $g o$ for his second strike, even though it cost him Combined in the end. For me, the rest of the season is gravy, but hang on while I give you the rest of the story.

The next to last event is a Slalom at Kissing Bridge, with a GS for the snowboarders. The team puts five racers on the hill, and scores another convincing win over Goodyear with 70 total points. Therese brings home her first trophy (baptized virgin hardware!) with a second in CCVW. Unfortunately, Barb get ahead of herself and skis through the flush. Again. Tim skis strong to bring home second in CM. Mark places in two events, with a third in BM and another third (more baptized virgin hardware!) in CSB.

To finish the season, the team takes to the hill at Swain in the dual GS. With two racers in three events, we don't have the numbers to keep up with Goodyear, but we finish well individually. Barb is back in her element in the speed events, conquers the headwall, and brings home a second in CCVW. Mark finds the groove and comes up big with a fourth in BM and a second
(more hardware!) in CSB. Goodyear pulls away to win the season point contest for the Best Little Team in Metro, but with our new numbers in CCVW, and new found proficiency in snowboard, they better look out next year. The eliminations on Sunday at Swain are just for fun, and fun they were. Metro's version of March Madness means you run untilyou lose. The snowboarders get the hill first, but Mark makes an early exit, losing in the first round to Karen Petit, who climbed the fastest. Barb has a two run day, and hangs on to beat Bootsie for her first (but certainly not last) win in CCVW. Mark makes it into the consolation round in BM, and runs the closest finish of the day, coming from behind to beat Mike Smith by 0.012 seconds for third place. Six runs really take it out of you!

All in all, it was a great season, with great racing, new racers and winning performances by the team and individuals. Look out for next season. I'll be getting you updates on the Wednesday Night Series, as soon as I can get results from the organizers. Thanks to all who came out to race for the team, and cheered us on from behind the fences. See you next season, on the race hill.

Constitution Review Committee 2005, proposed changes to the Constitution of the Lewis Ski Club, Inc.

All changes are to the version dated September 2003. The following 8 changes are recommended for general club consideration. Discussion will be held at the April meeting. A vote will be taken on these changes at the June meeting. Please read these over and come to the April club meeting with your questions, comments, and/or concerns.

## Proposed Change \#1

In ARTICLE II: PURPOSE, add the word "additional" to the first sentence. Added word is underlined in the text below.
"The purpose of this organization is to form an active, non-profit organization which provides skiing and additional social activities to its members; to promote and develop organized skiing, ski instruction, ski safety, skill and education; to encourage conservation of natural resources in and around ski areas; to support other non-profit ski organizations such as the Cleveland Metropolitan Ski Council, other ski clubs, the United States Ski Association, the USSA Ski Team; to assist and support charitable organizations including skiers with disabilities."

## Proposed Change \#2

In ARTICLE III: MEMBERSHIP AND VOTING, Section 1: Club Membership, edit the text as follows, and add the sentence on age for individual members.

## From:

Membership will be open largely, although not necessarily exclusively, to Glenn employees and/or members of their families. Lewis Ski Club, Inc. offers individual and family memberships. A family membership allows the immediate family, defined as a member and spouse and/or dependent children, to participate in club activities.
To:
Membership will be open to Glenn employees and/or members of their families and any other interested parties. Lewis Ski Club, Inc. offers individual and family memberships. A family membership allows the immediate family, defined as a member and spouse and/or dependent children, to participate in club activities. Individual members must be at least 18 years old.

## Proposed Change \#3

In Article IV: GOVERNMENT, Section 8: Consecutive Terms, limit the term limits to the offices of President and Treasurer.

## From:

No officer shall hold the same office for a period of more than three consecutive terms. To:
No president or treasurer shall hold the same office for a period of more than three consecutive terms.

## Proposed Change \#4

In Article IV: GOVERNMENT, Section 13: Spending Policy, increase the spending thresholds. From:
All non-recoverable expenditures shall require the following approvals prior to the expenditure: $\$ 0.00$ through $\$ 50.00$ - approval of at least two members of the Executive Board; $\$ 50.01$ through $\$ 100.00$ - approval of the Executive Board; anything above $\$ 100.01$ approval of simple majority of the members present at a regularly scheduled meeting (quorum required).

## To:

All non-recoverable expenditures shall require the following approvals prior to the expenditure: $\$ 0.00$ through $\$ 100.00$ - approval of at least two members of the Executive Board; $\$ 100.01$ through $\$ 200.00$ - approval of the Executive Board; anything above \$200.01approval of simple majority of the members present at a regularly scheduled meeting (quorum required).

## Proposed Change \#5

In ARTICLE V: DUTIES OF OFFICERS, Section 1: President, $6^{\text {th }}$ sentence, add the word "Coordinator's" to clarify and be consistent with the name of the Activity Coordinators Guide. From:
The President shall promote publication and review of the Activity Guide on an annual basis. To:
The President shall promote publication and review of the Activity Coordinator's Guide on an annual basis.

## Proposed Change \#6

In ARTICLE V: DUTIES OF OFFICERS, Section 8: Board of Trustees, change the first sentence in the $3^{\text {rd }}$ paragraph to read an annual report, instead of semi-annually.

## From:

The Board of Trustees will provide the members with a semi-annual, written report of their activities.
To:
The Board of Trustees will provide the members with an annually written report of their activities.

## Proposed Change \#7

In the BYLAWS, 4. DUES, ACTIVITY FEES, NON-REFUNDABLE DEPOSITS, AND REFUNDS, update the dues to our current dues. (Note: No real change, just correcting the paperwork!)

## From:

Dues shall be $\$ 8.00 /$ year for an individual membership and $\$ 12.00 /$ year for a family membership when paid on or before November 15th. The membership dues shall be $\$ 10.00 /$ year for
an individual membership and $\$ 15.00$ year for family memberships when paid after November 15 th, except for first time members where the $\$ 8.00$ and $\$ 12.00$ amounts shall apply as above. The dues will cover membership from October 1 to September 30 of the following calendar year.
To:
Dues shall be $\$ 10.00 /$ year for an individual membership and $\$ 15.00 /$ year for a family membership when paid on or before November 15th. The membership dues shall be $\$ 15.00 /$ year for an individual membership and $\$ 20.00 /$ year for family memberships when paid after November 15th, except for first time members where the $\$ 10.00$ and $\$ 15.00$ amounts shall apply as above. The dues will cover membership from October 1 to September 30 of the following calendar year.

In the BYLAWS, Attachment A. We propose deleting the attachment. (Sorry, could not be reproduced here.) Attachment $A$ is a flowchart and is more appropriately placed in the ACtivity Coordinator's Guide.
