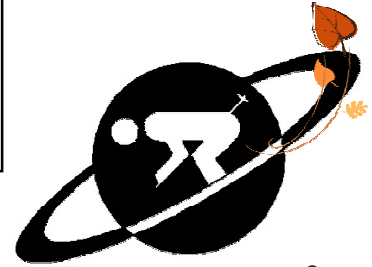

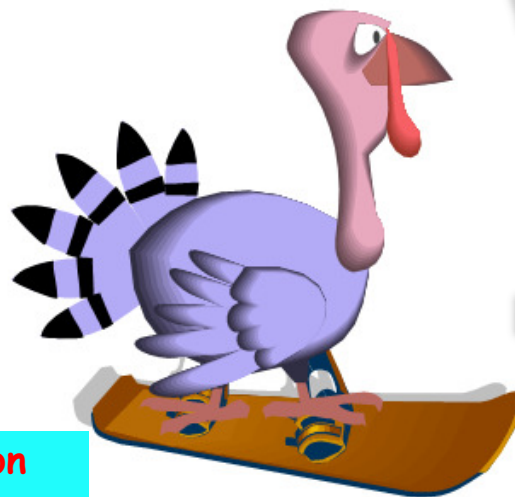

Penitentiary Glen Hike October 3rd

It seemed as if we were going to have a soggy hike according to the weather forecast, but 12 people (Alan

We soon found out that we did not need them—the weather turned out to be perfect for hiking. We had sunshine to start the hike, and later the clouds came in, but no rain. We climbed down 141 steps into the gorge and had a beautiful view of Stoney Brook Falls. The uphill climb got everyone a jump start for their ski season workout; it was definitely cardio! We went to

see the remnants of the Halle family summer home (front and back porch), entrance to the family bridge crossing the creek (the bridge is long gone), and the swimming pool in the creek.
