Racing News

The NASA Ski Team has been having another excellent year in 2010. Since our last report, 8 more races have been held in the CMSC Weekend Race Series, including Bristol Combined this last weekend. NASA has fared well in all, with the exception of Cockaigne, where we had no one competing. Overall, we stand 5th in Division II, with one race to go. It will be up to Mark to hold off the charge of Erie Shores at Swain 2.

Full results are included in the table for your information. In the Olympic spirit, let me summarize the medal count since the Kissing Bridge race. We were shut out of the medals at Peek-N-Peak, but showed up strong at Boston Mills with nine racers. Cheryl Alden took 3rd in BW, and Bruce Frankenfield took 3rd in CSB. The Swain 1 GS had Elise Frankenfield earning a 2nd in CCVW, and Bruce another 3rd in CSB. Lisa Lambert brought home a 3rd in BW in the slalom on Sunday.

Lastly, Bristol Combined proved a complete test of our racing mettle once again. The Super G netted a 1st in CCVW for Elise, a 2nd in BW for Lisa, and 3rd in BBVM for Bruce. The GS had its share of thrills and spills thanks to Mark's crashes, but highlights included another 1st for Elise and a 3rd for Lisa. The Slalom on Sunday proved to be the usual test of skill and endurance. Elise proved herself equal to the task, taking home another 1st, with Cheryl gaining a 3rd in BW. They call it Combined for a reason, and just as in the Olympics, the total time for all five runs determines the Champion in each class. In case you couldn't figure it out, if you win all three races, you will have the lowest combined time, and that's exactly what Elise accomplished. Congratulations Elise on a terrific Championship! On the Team front, NASA combined for enough points to take 4th out of eight teams competing in Division II.

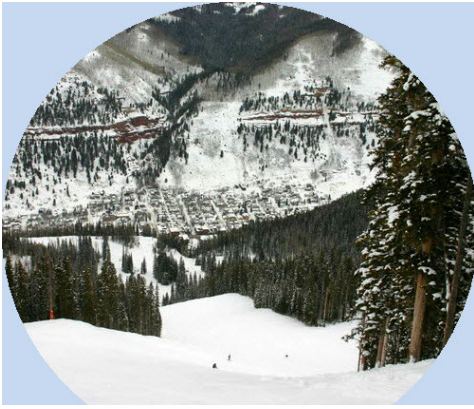

This was a trip filled to the brim with enjoyment and overflowing with memories lasting for a long time. Wish you could have been there to experience it! Hope you can join us on our next trip.

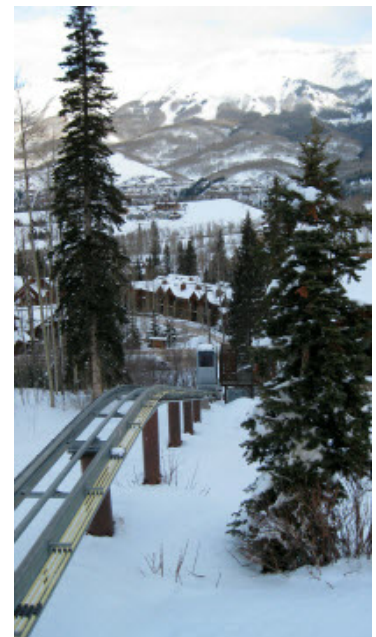
Here are some highlights of the trip and quotes from members:

PRESIDENT: The President presides at all Club meetings, appoints chairpersons for all committees, and is a standing member of all committees except for the Nominating Committee. He/She shall promote publication and review of the Activity Coordinator's Guide on an annual basis. He/She shall perform all duties incident to the office. He/She must be an on-site employee at the NASA Glenn Research Center.

ALPINE VICE-PRESIDENT: The Alpine V.P. is responsible for overseeing the Club's downhill ski and snowboard programs, issues the Activity Guide, in conjunction with the Nordic V.P. and Activities V.P., to each Activity Coordinator, and performs the duties of the President in the absence of the President or as delegated by the President.

NORDIC VICE-PRESIDENT: The Nordic V.P. is responsible for overseeing the Club's cross country ski program, issues the Activity Guide, in conjunction with the Alpine V.P. and Activities V.P., to each Activity Coordinator, and assists the Alpine V.P. in performing the duties of the president.

ACTIVITIES VICE-PRESIDENT: The Activities V.P. is responsible for overseeing all the activities other than those associated with the club's on-snow program including, but not limited to, biking, inline skating, canoeing, white water rafting, parties, and other such recreational activities, issues the Activity Guide, in conjunction with the Alpine V.P. and Nordic V.P., to each Activity Coordinator, and assists the Alpine V.P. and Nordic V.P. in performing the duties of the president.

RECORDER: The Recorder shall keep accurate and complete minutes of all meetings and report them to the Club members. He/she shall notify the members of the Board of all Board meetings.

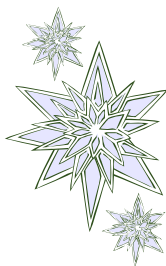
PUBLICITY DIRECTOR: The Publicity Director shall have charge of all club publicity, oversee distribution of the club newsletter, notify all members of all club meetings and perform all other duties incident to the office.

TREASURER: The Treasurer shall handle the general funds of the Club, keep an up-to-date record of all Club finances, and report receipts, disbursements, and account balances at the monthly membership meeting.

TRUSTEES: The Board of Trustees will provide guidance and oversight of the activities of the Lewis Ski Club, Inc. The Trustees shall be guardians of this Constitution, and shall be responsible to the members to ensure that all articles and sections of this governing document are followed. The Board of Trustees, along with club Treasurer, will perform the annual audit of the club treasury. The Board of Trustees, along with the President and Vice Presidents, will perform an annual review of the Activity Guide. The Board of Trustees will provide the members with an annually written report of their activities. Verbal reports will be given at club meetings. The Trustees will not be voting members of the Executive Board.

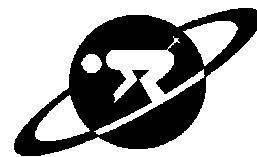

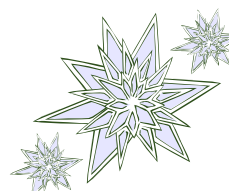

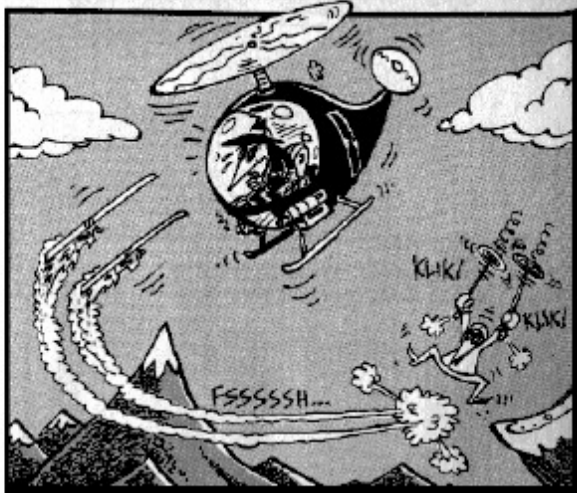

1. **DEPOSIT:** The required initial deposit for this trip must be paid and submitted along with a signed Trip Application and Agreement. Balance shall be due and payable in accordance with payment schedules established by Lewis Ski Club.
2. **WITHDRAWAL & CHANGE:** Lewis Ski Club may withdraw any trip from its schedule at any time; may refuse to accept or retain any person as a participant at any time for any reason; and may change the itinerary at any time.
3. **RESPONSIBILITY:** Lewis Ski Club is acting gratuitously for the applicant and shall not be responsible or liable for any loss of damage to baggage, property, or for any loss, injury, death, accident, delay, inconvenience or any other loss occurring during or occasioned by applicant's participation or lack of participation in any trip.
