

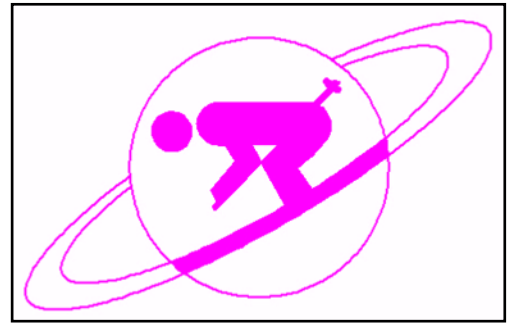

The 2014 CMSC weekend race series kicked off at Holiday Valley on January 4-5<sup>th</sup> with a large contingent of racers. The team had an awesome start in the GS on Saturday with Marilyn, Bruce, and Edie winning gold medals and Don L winning silver in skiing. Mark won gold on his board. Edie did so well that she got reevaluated from CCVW to BVW. The team finished 2<sup>nd</sup> overall in Division II – the highest ever! On Sunday, there were a number of DQs racing Slalom on the evil Edelweiss, but Marilyn repeated with another gold medal and Don L won silver again. Renee, Lisa, and Elise earned bronze medals. The team finished a respectable 5<sup>th</sup> overall.

On the weekend of January 18-19<sup>th</sup>, the team headed to Swain and rocked in the icy GS on Saturday. Every racer on the team medaled! For the skiers, Marilyn and Don L earned gold; Tom, Lisa, and Elise earned silver; Renee and Bruce earned bronze. On snowboard, Bruce and Tom earned gold, and Mike earned silver. 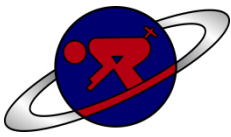

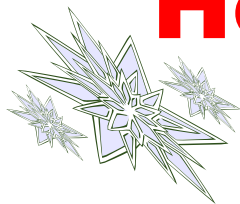

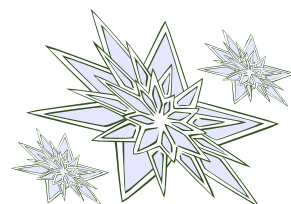

The undersigned participant applies to participate in the Lewis Ski Club trip described below, subject to the following terms and conditions:

1. **DEPOSIT:** The required initial deposit for this trip must be paid and submitted along with a signed Trip Application and Agreement. Balance shall be due and payable in accordance with payment schedules established by Lewis Ski Club.
2. **WITHDRAWAL & CHANGE:** Lewis Ski Club may withdraw any trip from its schedule at any time; may refuse to accept or retain any person as a participant at any time for any reason; and may change the itinerary at any time.
3. **RESPONSIBILITY:** Lewis Ski Club is acting gratuitously for the applicant and shall not be responsible or liable for any loss of damage to baggage, property, or for any loss, injury, death, accident, delay, inconvenience or any other loss occurring during or occasioned by applicant's participation or lack of participation in any trip. Trip participants ski and/or snowboard at their own risk. It is the injured skier's/snowboarder's responsibility to report to Ski Patrol for treatment or referral to hospital/doctor.
